As a responsible member of Westminster College, out of concern for the welfare of myself, my peers, my Fraternity, and other members of the public and in the furtherance of the high ideals of my College, I agree to abide by the following conditions during _____ (event) to be held on _____ (date) and sponsored by _____ (organization).

1. I will abide by Westminster rules and my fraternal laws concerning alcoholic beverages.
2. I will abide by the laws and ordinances of my state and city concerning alcoholic beverages as well as any relevant university regulations. This shall include but shall not be limited to the following:
 - I will not consume alcoholic beverages if I am not of legal age.
 - I will not use false identification.
 - I will not loan my ID to another person.
 - I will not provide alcohol to an intoxicated or underage person.
 - I will not transport alcohol in an open container.
 - I will not drive if I have been drinking.
3. I accept responsibility for my actions and those of my date/guest as well as any that I may cause.
4. I will be appropriately dressed at all social events.
5. My behavior will be a credit to my Fraternity/Sorority and College. I will give particular attention to language, smoking, and actions with my date.
6. I will abide by the transportation policy established for the event.
7. I will not consume any illegal drugs or controlled substances at social events.
8. I understand that the House Discipline Committee and the College will take appropriate actions if I fail to behave in a mature and a responsible way.
