In EDU 231, our students learn about IEPs, 504s, and the general background for UDL (Universal Design for Learning). We explore how quality teaching should meet the needs of all learners by accommodating, differentiating, and scaffolding lessons. We place students strategically in field so they experience a variety of classrooms – class within a class concept (area schools all call this something different), AVID classrooms, ELL classrooms, etc.)

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students are trained in the details of IEPs in EDU 231, they then observe the practical application during Practicum II, and in EDU 453 (Classroom Organization and Management) they are required to include IEP accommodations in their unit plans. In EDU 221, educational psychology, they also learn the history behind IEPs, 504s, and all other associated programs.

c. Effectively teach students who are limited English proficient.

Our students all must spend some of their hours in field in an ELL setting to give them experience working with ELL kids. Our students also learn a great deal about ELL in various ed prep classes (EDU 231, EDU 385 Diversity, and EDU 453).
