

**CARES Act HEERF III (Part II) Student Emergency Grant Reporting
March 10, 2022**

Higher Education Emergency Relief Fund Quarterly Report In accordance with the reporting requirements of the Higher Education Emergency Relief Fund – Emergency Financial Aid Grants to Students, Westminster College (MO) is reporting the information below in satisfaction of the Quarterly Reporting requirement. Westminster College (MO) received the CARES Act HEERF III grant award notification on May 12, 2021. As required, the information is provided to the Department of Education through our public website on a quarterly basis until the report is final.

1. The total amount of the funds awarded from the Department of Education pursuant to Westminster College’s Certification and Agreement for HEERF III Emergency Financial Aid Grants to Students was \$978,100.
2. Degree seeking students enrolled for the Fall 21 semester as of September 27, 2021 were awarded HEERF III Student Emergency Grants totaling \$580,200. Degree seeking students enrolled for the Spring 22 semester as of January 31, 2022 were awarded the remaining \$397,900 HEERF III Student Emergency Grants. The total amount distributed to the students for Spring 22 was \$397,949 which included \$49 of funds from the institutional portion of the HEERF III distribution.
3. The Spring 22 Student Emergency Grants in the amount of \$397,949 were distributed to students using the following criteria:

4. Emails were sent to students on February 7 to confirm if they were eligible for HEERF III Student Emergency Grants.
5. In the February 7 email, eligible students were asked to complete a Disbursement Authorization Form by February 17, 2022 if they wanted to apply their Student Emergency Grant to their outstanding student account balance. Checks will be distributed to students who did not complete the Disbursement Authorization Form
6. An email was sent to eligible students on March 8, 2022 to notify them their check was available to pick up in the Business Office by March 15, 2022. Checks that are not picked up will be mailed to the students’ home permanent address. The total amount of HEERF II Student Emergency Grants distributed to students was \$397,949.
7. The total number of students enrolled at the institution as of January 31, 2022 and thus eligible to receive Emergency Financial Grants to students under Section 18004(a)(1) of the CARES Act is 645 students.
8. Information provided to students concerning the Emergency Financial Aid Grants were communicated in individual emails to current students. The communication is provided below.

On March 11, 2021, the American Rescue Plan (ARP) was signed into law which provided funding for Student Emergency Grants through the Higher Education Emergency Relief Fund (HEERF) III. This email confirms, you are ELIGIBLE for the HEERF III funding.

The amount you are eligible to receive is \$875. To confirm your eligibility, we took the 2021-22 FAFSA results and your Spring 22 semester enrollment status into consideration.

If you currently owe an outstanding balance, your Student Emergency Grant can be applied to your student billing account to reduce your outstanding balance for the spring semester. To have the funds credited to your student billing account, you must complete the Student Emergency Grant Disbursement Authorization Form on the Finances tab in MyWC at <https://mywc.westminster-mo.edu/ICS/> by Thursday, February 17. After receipt of the form, the funds will be credited to your student billing account by Friday, March 11.

If you do not complete the Authorization Form, the Business Office will generate a check for you by Friday, March 11. You will receive an email from the Business Office when the check is available for you to pick up in the Business Office.
